Decision draft:

The Ordinary General Meeting of the Shareholders approves the renewal of Mrs. Valerie Marcelle Paule VILLAFRANCA's mandate as director, for a four-year period, starting to July 13, 2024 and empowering Mrs. Liliana IONESCU - FELEAGĂ, independent member of the Bank's Board of Directors, to sign, on behalf of the Bank, the Management Contract with her.

CONTEXT

- The expiry of Mrs. Valerie Marcelle Paule VILLAFRANCA's mandate as director starting to July 13, 2024;

- ✓ Other functions occupied are: Analyst in Business Consulting Practice on Arthur Andersen Neuilly sur Seine (September 1st, 1994– December 31, 1996); Consultant in Business Consulting Practice on Arthur Andersen Boston (January 1st, 1997 – June 30,1998).
- ✓ In March 18, 2018, she joined Société Générale as Group Head KYC Transformation, CPLE/KTP Société Générale and she occupied this position until October 19, 2021.
- ✓ Currently, since October 20, 2021, she is Group Head of ESG Transformation (ESG by Design program).
- ✓ In BRD, since July 13, 2020, she holds the position of Member of the Board of Directors of BRD-Groupe Société Générale S.A.
